### Determinants of Informal Cross-Border Trade: The Case of Benin

AGRODEP released a new working paper this month. "Determinants of Informal Cross-Border Trade: The Case of Benin" focuses on Benin's exports and re-exports to its neighbors to examine the determinants of formal vs informal trade.

The authors find that agricultural products are traded mostly informally and that trade policies (specifically tariffs and import bans) play a significant role in explaining informal trade.

### Welfare Effects of ICTs in Agricultural Markets: A Case of Selected Countries in East Africa

A second new working paper, <u>"Welfare Effects of</u> ICTs in Agricultural Markets: A Case of Selected Countries in East Africa", examines several specific ICT portals in Rwanda and Kenya that are being used by both traders and farmers to access agricultural market, price, and input information. The study finds mixed results for the effect of ICTs on the welfare of these two groups.

#### 2016 ReSAKSS Conference Held in Ghana

The 2016 ReSAKSS Conference took place this week from October 18-20 in Accra. Ghana. The theme of this year's conference was "Achieving a Nutrition Revolution for Africa: The Road to Healthier Diets and Optimal Nutrition." The conference was organized by IFPRI and the African Union Commission (AUC).

The conference discussed recent regional efforts to address Africa's nutrition needs, including the CAADP Nutrition Initiative and the 2014 Malabo Declaration. in order to better understand how these various initiatives can be leveraged and coordinated to make more rapid progress on the region's nutrition targets.

Among the speakers at the conference were Ousmane Badiane, co-chair of the AGRODEP Steering Committee, and Maximo Torero, co-chair of the AGRODEP Scientific Advisory Board.
