New NAIP Toolkit for Modeling Agricultural Growth and Investment Strategy

Recent research from Ismael Fofana of IFPRI, AGRODEP member Miriam W.O. Omolo, and co-authors Anatole Goundan, Léa Vicky Magne Domgho, Julia Collins, and Estefania Marti uses a simulation model to identify country-level priority areas for agricultural investment and track progress toward achieving Malabo goals. Under the Malabo declaration, African leaders committed to focusing on agricultural-led growth and targeting other goals including: halve poverty, end hunger, double agricultural productivity, triple intra-African trade, strengthen public-private partnerships in priority value chains, and many others, all by 2025.

The simulation model developed by this team consists of a three-component framework to capture progress toward Malabo goals composed of a stochastic meta-frontier technique, a computable general equilibrium model, and microeconometric analysis. This modeling framework is implemented on Kenya using several recent datasets from the Kenya National Bureau of Statistics as well as a 2013 Social Accounting Matrix for Kenya (Randriamamonjy and Thurlow, 2017). Results from the simulation suggest that the growth in Kenyan nonagricultural sectors would not be enough to achieve Malabo goals on poverty and hunger, but agricultural-led growth with social assistance could lead to achieving Malabo commitments by 2025.
