### **AGRODEP Announces Call for Gaps in Research Grant Proposals**

AGRODEP recently announced its second annual call for its "Gaps in Research" grant series. These grants support research on emerging issues in Africa that previously received little or no attention.

The theme of this year's grant is "Barriers to the extension of agriculture and agroindustry in Africa." Successful proposals will shed light on at least one of the following topics in the context of Africa: impact evaluation of government policy in development of infrastructure for agricultural production, irritation, or transportation; access to fertilizers; advisability of seed and fertilizer subsidies; rural and agricultural structural projects; impact of regional integration; and value chain analysis for key agricultural commodities. Methodologically, proposals may use impact evaluation methods, CGE models, partial equilibrium models, or any combination thereof. Priority will be given to proposals utilizing "outside-the-box" modeling and research.
