Climatic Risk, and Environmental Sustainability with Simulation Models training course will be instructed by Gerrit Hoogenboom of AgWeather Net and Washington State University and Jawoo Koo of IFPRI. The course will familiarize participants with the simulation of crop growth and yield, soil and plant water, nutrient, and carbon dynamics, and their application to real-world climatic challenges. Specifically, the course will utilize the DSSAT Cropping System Model (CSM), a general cropping system model for simulating crop growth and development and soil and plant water, nitrogen, and carbon dynamics.
