2014 Innovative Research Grant Launched

AGRODEP has launched its annual competitive grant call for proposals on "Innovative Research." Proposals for this grant are only accepted from current AGRODEP members. The theme of this call is "Linking Country Policies to Agricultural Development Outcomes "

Under this theme, research projects may focus on any topic and policy that is at a stage of implementation where it can be evaluated. Some suggested topics include trade policies, agricultural policies, and climate change. Specific policies chosen for analysis should fall under the general topic. Analyses can be conducted on any African countries or regions, but AGRODEP strongly encourages research on policies in one or more of the following countries: Burkina Faso, Ethiopia, Ghana, Malawi, Mozambique, Senegal, Tanzania, Uganda, Kenya, Benin, Democratic Republic of the Congo, and Togo.

AGRODEP encourages members to submit joint proposals, particularly with members from other countries.

Proposals must be submitted by December 1, 2014.
