THE MEMBERSHIP ACTIVITY REPORT - YEAR 2012

March 2013

The Membership Activity Report provides useful information on member's involvement in AGRODEP activities with the objective to better tailor the consortium's future activities to the needs of its members. Activities implemented by AGRODEP in 2012 have recorded an increasing number of participation (47) among members (55). Members' participation rate has improved from 56 to 85 percent in average between 2011 and 2012. Among the activities, training courses recorded the highest participation among members in 2012. On the other hand, members have not shown a strong interest in the publication support activities provided by AGRODEP Management Team, so far.

I. ABOUT AGRODEP

The African Growth and Development Policy (AGRODEP) Modeling Consortium is an initiative led by the International Food Policy Research Institute (IFPRI) that aims at positioning African experts to take a leading role in both the study of strategic development questions facing African countries as a group and the broader agricultural growth and policy debate, which traditionally has been dominated by external actors and concerns. Building on more than three decades of research and capacity-building activities in Africa, IFPRI and its partners aim at providing locally relevant solutions to agriculture-related development challenges.

AGRODEP is collaboration among IFPRI; the Association for Strengthening Agricultural Research in East and Central Africa (ASARECA); the West African Council on Agricultural Research and Development (CORAF/WECARD); and the Food Agriculture and Natural Resources Policy Network (FANRPAN).

The Modeling Consortium pursues three essential activities:

 Promote the access to state of the art economic modeling tools and improving the quality, relevance, and timeliness of data to meet the significant demand for high quality, locally-based research that contributes to evidence-based policymaking and strategy planning and implementation;

- Facilitate better access to the existing data sources for research and policy analysis, developing
 methodologies and standards to improve the quality of available datasets and complementing them
 to raise the local content and relevance;
- Support collaboration among leading African scientists and their peers outside Africa, building a
 dynamic research community that can respond to the emerging and long-term needs of the
 Comprehensive Africa Agriculture Development Program's (CAADP) growth and poverty
 reduction agenda.


II. AGRODEP NETWORK ACTIVITIES IN 2012


1. MEMBERSHIP EXTENSION


On January 2012, AGRODEP membership reached fifty-five (55) Africa-based researchers with quite diverse research interest and experience. On April and October 2012, AGRODEP welcome twenty-nine (29) and thirty-six (36) new members. The two rounds of selection have extended the membership to one hundred and eighteen (118) members coming from twenty-seven countries in Africa with thirty-three (33) female researchers.

AGRODEP Management Team used the same selection criteria as in previous membership rounds. First, applicants must be based in Africa and have obtained a PhD within the last 15 years, or currently pursuing a PhD program, or have a Master's degree combined with technical skills and experience. The second set of criteria relates to research experience as evidenced from publications and any further training and workshops attended. Finally, as needed, regional, gender, and scientific diversity is ensured in the composition of members.

2. TRAINING PROGRAM

In 2012, AGRODEP has offered **eight** (8) **training courses** to its members. The training courses were designed on the basis of AGRODEP members' preferences from a survey conducted in September 2011. The courses, which details are available in table 1, include training on:

- Building and Updating Social Accounting Matrices
- Poverty Measurement and Analysis
- Computable General Equilibrium Modeling using GAMS Basic
- Household Surveys Data: Sampling and Processing
- Panel Data Econometrics
- Impact Evaluation & Analysis of Development Interventions
- GAMS-based Computable General Equilibrium Modeling Advanced
- Multicountry and Multisector General Equilibrium Analysis MIRAGRODEP

AGRODEP has offered **34 days** of training courses with a total number of **83 attendees** among members. AGRODEP conducts course evaluations to find out whether the course was useful to the participants and to identify areas of potential improvements that can benefit future trainings. All courses have generated appreciation from the participants and valuable positive feedback that AGRODEP will use when designing the training program for 2013.

3. GRANTS PROGRAM

Grants for Innovative research

In October 2011, AGRODEP approved funding for 14 out of 28 research proposals submitted by 31 AGRODEP members. 8 proposals cover one year of research. 6 proposals fall under the CAADP category of AGRODEP's Grants Program which seeks to identify the existing policies proposed and implemented under the CAADP Agenda and to perform a systematic assessment that identifies the major bottlenecks affecting the efficiency of such policies. The CAADP grants cover two years of research. Additional information is available in table 2.

Gaps in Research Grants

In 2012, AGRODEP has selected for funding 3 proposals to address gaps in research among a total number of 75 applications. This type of grant is opened to AGRODEP members as well as to non-

member individuals and organizations worldwide. The Gaps in Research grant was launch in May 2012 and aims to support research on emerging issues in Africa that have previously received little or no attention. In 2012, the call for proposals focuses on any or all of the three sub-topics of the following theme: Foreign Direct Investment in Land (FDI), Land Markets and Land Institutions, and Development of the Agricultural Sector in Africa. Encouraged to apply are researchers or research organizations that have already engaged in some capacity in addressing the issues but could use the grant funds to complement their efforts and produce high quality research.

Research Valorization Grant

AGRODEP offers a Research Valorization Grant which allows members to apply for financial support from the Consortium in order to present the outcome of their research to various audiences. In 2012, AGRODEP has awarded 23 grants out of 27 applications under this program. This includes 8 AGRODEP members that were selected for sponsorship by the World Trade Organization (WTO) to attend and present their work at the 15th Annual Conference on Global Economic Analysis on June 27-29, 2012 in Geneva, Switzerland. Also, 11 members attended the AGRODEP Workshop in Dakar, Senegal, on November 13, 2012. This scientific gathering was an opportunity for the invited members to present their ongoing research work. 6 members presented their preliminary results of their AGRODEP funded project.

4. PUBLICATION SUPPORT PROGRAM

Working Paper Series

The AGRODEP Working Paper Series is a bilingual (English and French) online publication that aims at enhancing the visibility of African researchers worldwide. The Series has received 10 submissions since its launch in September 2011. Thus far, 1 paper has been published on June 19, 2012 and 6 remain under review with a seventh withdrawn from consideration.

Award for Excellence in Publication

In November 2011, AGRODEP announced the Award for Excellence in Publication. The objective of this award is to provide incentives for, and to reward excellent publications by AGRODEP members in top ranking academic journals. The announcement drew positive response from AGRODEP members with 5 unsuccessful applications. AGRODEP continues to encourage its members to apply for this program and hopes that this initiative will increase their visibility both within and outside of Africa and contribute to AGRODEP's overall policy impact.

Post-Training Collaborative Research and Publication

AGRODEP training courses give an opportunity to its members to engage in mentoring and collaborative research activities twelve months after the training courses. Incentive is given to members and instructors to undertake such activities. The objective is to continue strengthening members' capacities in modeling tools and techniques and enhance partnership with the international modeling community. In 2012, 1 post-training mentoring activity has been recorded.

III. PARTICIPATION TO AGRODEP ACTIVITIES IN 2012

AGRODEP promotes and facilitates the access of African researchers to cutting edge methods and tools, and data that will enable them to perform science-based research and to formulate sound and effective policies. This section of the report provides useful information on member's participation to activities offered by AGRODEP in 2012. Through a calculation of participations and activities rates, the 2011 report provides a simple measurement of the networking activities.


Regarding the calculation of these rates, a matrix indicating the members in its line and the above mentioned activities in its column is elaborated. The number one is given to a member who participated to a given activity, and zero in the other case. The maximum number of participants in a given activity is equal to the total number of members. Participation and activity rates are then calculated on the basis of this information. Participation rates are computed on the lines and divide the sum of participations in all activities by the total number of activities offered by AGRODEP. Activity rates are computed on the columns through the ratio of total participation of members to that activity and the maximum number of participations. The overall activity rate is a simple average giving the same weight to all activities. The main information brought by the analysis of members' participation to AGRODEP activities is summarized throughout the following lines.

- ❖ Among the 55 members who join the consortium in 2011, 85 percent have participated at least in one program (training, grant, or publication) implemented by AGRODEP in 2012 (Figure 2). A large number of members (22) have been involved in two of the three programs over 2012; the number of members who participated in one program was also important (17). However, a small number of members (8) did not participated to any program implemented by AGRODEP in 2012.
- ❖ 2011 Members have shown the highest participation rates in AGRODEP activities as compared to 2010 Members. Members who join the consortium in early 2012 have also contributed to the activities.
- ❖ Training courses recorded the highest participation rate among members. On the other hand, members has not shown a strong interest in the publication support activities Working Paper

Series, Award for Excellence in Publication, Post-Training Collaborative Research and Publication – provided by AGRODEP Management Team, so far.

Table 2 ranks AGRODEP members according to their involvement in the consortium activities in 2012.
