### **2013 Training Courses**

The first two 2013 AGRODEP training courses were held in Dakar, Senegal in May: [Impact Evaluation and Analysis of Development Interventions \(Part 1\)](#) and [Economic Impact of High Food Prices Using Micro Data](#). Fourteen AGRODEP members participated in the course on impact evaluation, while 11 members participated in the course on the economic impact of high food prices.
