# 1. Guidelines for AGRODEP Affiliate Membership



## Background

- Wider interest around the world to join the Consortium
- Relocation of AGRODEP members out of Africa

## Objectives

- Increase the exposure of AGRODEP members to their colleagues outside AGRODEP
- Accommodate relocated AGRODEP members outside Africa

## Who May Become an Affiliate Member?

- AGRODEP member who moves out of Africa
- Qualified African researcher who lives and works outside of Africa
- Qualified African and non-African researchers working in international and CG centers in Africa



## RIGHTS

#### • Participation

- Right to provide input and feedback on future AGRODEP activities to the network and project coordinators
- Access to Models and Data
  - right to use models and data for purposes of learning, teaching, and academic and scientific research

#### • Capacity Enhancing Activities

• Right to attend AGRODEP workshops, training courses, and conferences at <u>their own expense</u>

#### • Grant Program

- Eligible to apply for <u>non-restrictive AGRODEP grants</u> for their research projects (e.g. AGRODEP Grants to Address Gaps in Research)
- Moving to and living in Africa
  - Right to apply for regular AGRODEP membership



### RESPONSIBILITIES

#### • Access to AGRODEP Resources

- Access rights to data and models cannot be transferred to non-members of the Consortium
- responsible for maintaining the confidentiality of their log-in information to AGRODEP's online data and modeling portal
- Contribution to AGRODEP Activities
  - publication of AGRODEP peer-reviewed discussion papers
  - publications that acknowledge the help and support of AGRODEP
  - provision of documented databases or models to the network
  - <u>instruction of AGRODEP training courses</u>
  - <u>mentoring of AGRODEP members</u>
  - review of AGRODEP members' proposals, reports, and publications
- Participation in Networking Activities
  - interaction with their fellow members and affiliate members
- Code of Conduct
- Intellectual Property Rights



#### MEMBERSHIP APPLICATION, SELECTION, AND REVIEW

#### **Application Procedure**

- Fill out online application form at any time
- Invitation sent by AMT to members no more based in Africa
- Signed Letter of Agreement

#### **Selection** Criteria

- Education and Professional Experience
- Research Experience

#### **Selection Committee**

- Evaluation committee of five members (at least)
- Composed by AMT and representatives to Governance bodies

#### **Review of Affiliate Membership**

- Review process every two years
- Recommendation for affiliate membership withdraw submitted to the SC



# 2. Guidelines for Friends of AGRODEP



#### Background

- Successful continuation of AGRODEP activities relies on the contribution of individuals and institutions outside the AGRODEP network .
- Contributions of friends of AGRODEP include:
  - Documented databases and models
  - Proposed training courses
  - Instruction and participation in capacity-strengthening activities
  - Mentorship of AGRODEP members
  - Review of members' proposals, reports, and publications
  - Collaboration with members in various research or publication activities

#### Objective

• Recognize and formalize the contributions and benefits of AGRODEP collaborators





#### Who is a Friend of AGRODEP?

- Individual or institution
- Not an AGRODEP member or Affiliate member
- Active participation in AGRODEP activities within the past year

#### **Selection and Invitation**

- Identification and selection by AMT
- Invitation sent by AMT
- Highlighted on the AGRODEP web portal
- Access to non-public AGRODEP materials upon request and on a case-by-case basis
- Not imply a monetary contributions to or by AGRODEP
